**LOCATION:** Whitesburg Pool is located at 610 Sanders Rd, just behind Whitesburg Baptist Church off Whitesburg Rd.

**FACILITIES:** 6 lane, 25 yard pool, with non-turbulent lane ropes. Partial Colorado Timing System with digital time display; seating for 100 spectators. This meet is a Short Course Yard meet.

**ELIGIBILITY:** All age group participants must have been submitted to the RCSL as a rostered swimmer per applicable RCSL Rules of Competition rules. No entries will be accepted if not confirmed. Open participants should be sponsored from an RCSL pool. Every swimmer must have an identified sponsor during the meet (coach or parent). Swimming in this meet establishes official times for strokes and are eligible for seeding at City Meet. Swimming in the meet **DOES NOT** satisfy dual meet eligibility of 2 meets to swim at City Meet.

**RULES:** The 2011 USS rules and current RCSL Rules of Competition will govern the conduct of the meet unless noted otherwise herein.

**WARM UP:** The Meet Director will post and announce the warm-up assignments prior to the start of the meet warm-up.

**ENTRY FEES:** \$3.00 per individual event. NOTE: A surcharge of \$1.00 per swimmer, said surcharge being used for administration costs.

**Late entries** will be accepted at the discretion of the meet director. Late entries will be charged \$2 surcharge per swimmer, \$4 per individual event.

**ENTRIES:** A swimmer may swim four (4) events. Teams will use HYTEK's Meet/Team Manager to submit their entries. Template will be provided on the RCSL web portal.

All teams are asked to completely fill out the enclosed **Team Information Form**, including the names and contact numbers for all registered officials affiliated with the team that are willing to serve as a meet official during the weekend. ***Enter all events with the best official RCSL yards times. DO NOT CONVERT TO METERS. Entry times should be in hundredths (0.01). Please keep in mind you can use this meet get time results for swimmers in stokes/events they don't usually get to swim in dual competitions.*** Swimmers with disabilities are welcome. Please let the meet director know if accommodations need to be provided.

**SEEDING:** See attached list of events. All events are timed finals. Whitesburg Pool reserves the right to limit the number of heats in deck-seeded events in order to run the meet in the allotted time. Failure to swim a deck seeded event after signing in will result in the swimmer being barred from swimming his/her next individual event. **Only the swimmer or his/her coach may sign in for deck-seeded events.**

**DEADLINE:** All entries must be received by before **midnight Sunday, June 19, 2011. No late entries will be seeded.** *Entries will be accepted for a total of 250 swimmers.* Late entries may be accepted at the discretion of the Meet Director; however, they will be accepted on a "lane available" basis and may not appear on the heat sheet.

**AWARDS:** First, Second and Third place ribbons

**MEETING:** There will be a coaches'/reps' meeting at 8:00 AM, Saturday, 6/25/11. There will be an officials' meeting approximately 30 minutes before the start of the meet.

**SCRATCHES:** The Scratch Rules as shown in the current US Swimming Handbook will apply.

The meet director reserves the right to run this meet in a 4, 5, or 6 lane format depending on the number of entries received.

Entry error: If due to an Whitesburg Pool error, the swimmer will be deck entered in an open lane of the heat nearest his/her entry time or in a new heat. The entire event will not be re-seeded.
